CERTIFICATE OF ORIGIN INSTRUCTIONS

1. SHIPPER/EXPORTER

Name and address of principal party responsible for effecting export from the United States.

2. DOCUMENT NO.

Unique number assigned by the exporter to identify the document.

3. EXPORT REFERENCE

Any special reference numbers assigned by the exporter.

4. CONSIGNEE

Name and address of the party receiving the merchandise.

5. FORWARDING AGENT REFERENCES

Name and address of the freight forwarder

6. POINT AND COUNTRY OF ORIGIN

Actual country of origin for the goods.

7. NOTIFY PARTY

(a.k.a. Intermediate consignee) Name and address of the party in a foreign country who effects the delivery of the merchandise.

8. DOMESTIC ROUTING/EXPORT INSTRUCTIONS

Additional instructions for domestic routing or export.

9. PIER OR AIRPORT

Port or airport from which the goods are shipped.

10. DATE OF SHIPMENT

Date of actual export from the United States.

11. EXPORTING CARRIER (Vessel/Airline)

Name of vessel or air carrier and voyage number or flight number.

12. PORT OF LOADING

Port or airport from which the goods are loaded.

13. ONWARD INLAND ROUTING

Additional instructions for inland routing.

14. AIR/SEA PORT OF DISCHARGE

Port or airport from which the goods are discharged.

15. FOR TRANSSHIPPMENT TO

The final country where the goods will be transshipped.

16. MARKS AND NUMBERS

Any marking or information that are indicated on the shipping packages in which the goods are contained. Include any and all outside markings. "Number" refers to the numbering of the packages in the shipment (for example, "1 of 20")

17. QUANTITY

The total number of packages, cartons, boxes, skids, etc., per description line.

18. DESCRIPTION OF PACKAGES AND GOODS

Full description of items shipped, HTS codes, type of container and any additional information relevant to the description line. May also include cross-references to purchase order or commercial invoice numbers.

19. GROSS KILOS

Total weight of all packages, per description line, excluding outer packaging, but including inner packaging in kilograms.

20. GROSS WEIGHT (LBS.)

Total weight of all packages, per description line, excluding outer packaging, but including inner packaging in pounds.

21. MEASUREMENT

Dimensions of packaging containing all items included in the description line.
